### ***Chair's Corner:***

It is easy to participate in UUSJ! In fact, you are doing so by reading this newsletter. But there are many other ways to participate such as:

1. Join or attend a task force meeting. See the reports from our three task forces in this newsletter to find out how to do that.
2. Form a new Task Force. In addition to our three current task forces, we could have others, such as a Gender TF, Children's Issues, Global Issues, Etc. A new Task Force would require at least five members, representing at least three CAUUC churches, UUSJ Board approval, and regular meetings (usually three or more per year). Contact UUSJ if you would like to start a new task force.
3. Attend one of our public programs. UUSJ holds three to six programs yearly open to the public.
4. Join the Action Alert system which involves keeping you informed on social justice with several options for taking action on these issues if you so desire. Contact UUSJ and we'll send you a sign-up form.
5. Ask us to meet at your church. We hold our board and Task Force meetings at CAUUC area churches, or we can send a speaker to your church. Contact UUSJ to discuss arrangements.
6. Tell us about social justice actions and events in your church. Whenever possible and appropriate, we will announce your event at our meetings (we hold 12 to 15 meetings per year) and/or in our newsletter (three issues yearly). UUSJ Board and task force members frequently attend these events to support CAUUC churches.
7. And yes, we'll take your money! UUSJ is a 501(C)3 organization and contributions are tax deductible.

### ***Home and Hope Booster Grant***

At it's meeting on Oct. 11, the Task Force on Economic Justice and Homelessness approved the nomination of the DuPage Unitarian Universalist Church, for unreimbursed expenses in connection with it's Bridge Communities Partnership, in which it, for two years, rents an apartment, pays the utilities, and provides mentoring to a family that was homeless and is now, with help, on the road to economic independence.

Since October, 2006, DuPage Unitarian Universalist Church (DUUC) has supported a single mother and her two children, including providing three mentors, and maintaining a 6-member Bridge Communities Housing Team in support of the project. DUUC is continuing in the program, with a new family, starting Nov. 2008. The church's annual commitment (expense) to the partnership is \$9,180, with Bridge Communities picking up the balance of the expenses. In the past year DUUC raised \$7,160 toward it's obligation, including \$3,750 from an endowment fund, \$2,387 from special collections, and \$1,043 from Sleepout sponsorships. DUUC's volunteer time, devoted to the project in the last year, totaled 546 hours, including 300 hours of mentoring time, 96 hours in time devoted to the Housing Team, and remaining 150

hours devoted to fundraising for the project.

We congratulate DuPage Unitarian Universalist Church for its substantial volunteer involvement and financial support for its Bridge Communities partnership. As the result of the pledges collected in connection with this Home and Hope Booster Grant nomination, UUSJ was able to send a grant of \$500 to the DuPage U.U. Church, in support of its Bridge Communities Partnership.

### ***Other***

Unitarian Universalists for a Just Economic Community (UUJEC) is sponsoring a national conference, entitled *Revisioning Economics*, April 1-5, 2009, which will be held at a conference center in Rowe, Massachusetts. The cost to attend the full conference, including housing, is \$400. You may learn more about the conference by visiting the U.U.J.E.C. website.

During the last few months of the current Congress this task force did not initiate any new Action Alerts, but expects to do so regularly once the new Congress convenes.

## **UUSJ Environmental Task Force Report**

Action Alert: We sent out one to US House members encouraging them to support much more environmental legislation with the new Democratic Obama administration coming into office. More specifically, we seek: "major reductions in greenhouse gas emissions, and to get 20% of our electricity from clean, renewable sources within a decade, while creating many new green economy jobs to help jump start economic recovery."

Educational Inserts: We've completed and mailed one by Gene Horcher about the advantages of tap water over bottled water and another by Allan Lindrup on Water Filter Issues. Another one by Mary Alice Masonic about CFL bulbs soon will be mailed.

Program on Great Lakes Compact: Our Task force presented Frances Canonizado from the Alliance for the Great Lakes with a program on the Great Lakes Compact at the annual UUSJ meeting on 12/7/08. This agreement by all the US states bordering the Great Lakes and Canada prohibits piping, trucking, selling, or in any way removing more water from the Great Lakes basin than naturally falls there by rain. It also protects this huge fresh water resource from sewage, toxic waste and any more invasive salt water species such as zebra mussels. After the program, she answered questions.
